I am writing to you on behalf of the residents who reside on the eastern side of the Western Highway between Kennel Road and Pollard Lane and the western side between Morella Road and McLoughlin Road. We are very concerned about our safety when performing a right hand turn to enter our properties or exiting on the western side. We have previously requested a run off on the left- hand side of the highway to allow us to safely pull over to allow all vehicles in both directions to pass before making a right- hand turn. Both council and VicRoads have done some work but it is starting to degrade once again. With over 5,000 vehicles using the highway each day, it is a continuous stream of traffic every time we enter or exit our driveways.

I met with a council employee well over six months ago to ask if the two service roads that exist on the western side of the highway from Morella Road to Bridal Hill Road be joined up to allow us to use that road and then cross directly over the highway easily. He told me that the land in between is Crown land and that I needed to contact DELWP in Ballarat, which I have since done and attached is their reply citing council is the responsible authority.

We understand from the articles in the paper that Kennel Road and Morella Road entries were upgraded due to a safety concern by their residents. We ask that we be given the same consideration. If we had access to a service road, we could also use it as a walking track and bike path for children riding to school in safety, as both sides of the highway near our properties are very narrow and drop down steeply.

We would like to meet with you on site so that you can appreciate our concerns and work out a satisfactory solution.




